# A MESSAGE FROM RC22 PRESIDENT

Dear friends and colleagues,

The last two years continue to be very challenging since the onslaught of the COVID-19 pandemic and its variants that have visited the world with untold economic hardships, human loss, social disruptions, and unprecedented dislocations. The global pandemic forced us to adjust or change our lives to a "new normal," in ways we could never have imagined. The pandemic has impacted ISA programs and activities in a myriad of ways.

First, you will recall that the pandemic led to the cancellation of the *Fourth ISA Forum* of *Sociology*, Porto Alegre, Brazil in August 2020 and its subsequent change to a virtual Forum on February 23-28, 2021. Second, the uncertainty around a lingering pandemic crisis resulted in the postponement of the ISA World Congress of Sociology in Melbourne, Australia by a year, from 2022 to 2023. The delay of the Congress by a year was also to be able to hold it in person and on-site in Melbourne. The World Congress will be in a limited hybrid format, although it will be primarily an on-site event.

While the crisis is far from being fully over, we are grateful to the ISA Executive Committee (EC) for taking a bold step, after a series of consultations, to convene the XX ISA World Congress of Sociology, Melbourne, Australia, on June 25 – July 1, 2023.

The Congress theme: Resurgent Authoritarianism: Sociology of New Entanglements of Religions, Politics and Economies is rather auspicious and timely indeed. It is noteworthy that the main congress theme in 2023 is partly linked with the theme of religion. Also look out to the Presidential Opening Session on Liberalism, the Other and Religion, and the Closing Presidential Session: Building a Just Post-COVID-19 World.

Alas, the World Congress is upon us, barely one year from today. Our most profound gratitude goes to the RC22 Program Coordinators: Susan Carland (Australia); Olga Odgers Ortiz (Mexico); Conrad Hackett (USA) and Michael Okyerefo (Ghana) as chairperson. They have bent backward and worked tirelessly to prepare 22 session proposals under the conference theme *Religious Change in a Turbulent World*. An open call for individual paper and panel abstracts has been advertised since July 1 on the ISA website and in this latest RC22 newsletter. A number of these sessions, with interesting, wide-ranging themes and global/local/regional topics and focus, have been carefully put together by the Project Coordinators and session organizers. The fact that over 41 session proposals were submitted for consideration is a testament to the centrality of the RC22 conference theme but also the popular interest and support for RC22 Sociology of Religion programs.

#### Dear RC22 colleagues and friends, the ball is now in your court!



I enjoin you to submit individual and panel abstracts for consideration. Be reminded that potential participants must submit abstracts online to a selected session of RC22 through a centralized platform from July 1 - September 30, 2022. 24:00 GMT. What a pleasant delight that five years after the ISA World Congress in Toronto, Canada (2018), we are eagerly and hopefully looking forward to meeting again, in person, to enjoy meaningful intellectual encounters and exchanges, as well as social networking that is characteristic of a world congress.

We are also glad that a limited hybrid format is being considered to cater for members who are unable to attend in-person. This also means that your ISA and RC22 membership is renewed and up to date to be eligible to attend in-person and virtually. These continue to be difficult times financially, dwindling economies that would hamper some members' participation at the World Congress, especially from the global South. The ISA EC approved the creation of an ISA Solidarity Fund to boost student membership and to breach inequalities between sociologists in category A countries and those in categories B and C countries. The ISA Solidarity Fund Initiative and RC22 Grants would be added impetus to cushion registration and membership fees for some members.

The unintended impact of the COVID-19 pandemic is manifest in our families, local communities and in our own lives in myriad ways. The pandemic crisis has had deleterious effects on the ISA/RC22 body, members, and programs. It was with deep regret that we read the sad news of the passing of three distinguished senior colleagues and sociologists of religion in rather quick succession. James Beckford, Gary Bouma and Roland Robertson have made significant contributions to the development of the subfield of sociology of religion. Our hearts and prayers are with their family members, loved ones, and those others who are in critical health condition at this time. May their memories be a blessing! The RC22 Presidential Session II "Remembering the Contributions of Departed Scholars Including James Beckford, Gary Bouma & Roland Robertson" is convened in honor of these distinguished sociologists of religion, where several seasoned panellists will appraise their life, works and significant contributions to the subfield of sociology of religion.

We are also delighted to welcome Dr. Henrietta Nyamnjoh (University of Cape Town, South Africa) who will be presenting the keynote lecture, Stoking the Flames of Faith: The Challenge of Keeping Religiosity Activated in COVID and post-COVID 19 times, at the RC22 Presidential Session I.

One more unanticipated consequence of the pandemic is the prolongation, by one year, of the lifespan of the current RC22 officers and Board as well as the ISA EC. The RC22 Sociology of Religion Statutes (13) stipulates the election procedures for the Board. "Elections shall be organized by ballot at least one (1) month before the World Congress of Sociology. Not later than nine (9) months before the election date, the Election Committee will send members of the Research Committee 22 a notice of the election, together with a nomination form for the President, the Secretary-Treasurer, and for members of the Board" (13c&d). With regards to election details, please watch out for the call for nominations in mid-August 2022. In the meantime, my gratitude goes to the current RC22 officers and Board for their continuous dedication, passion, and resilience through this extended period of service to RC22 and ISA at large. We look forward to your unflinching support and participation in the World Congress in Melbourne in 2023.



Religious Freedom: Social – Scientific Approaches Olga Breskaya, Roger Finke and Giuseppe Giordan Annual Review of the Sociology of Religion, Volume 12, Brill 2021.

This volume offers original research on religious freedom from around the globe. Individual chapters address the issues related to defining and understanding the concept of religious freedom and incorporate sociological thinking into interdisciplinary analysis of this topic. By interpreting legal cases, analyzing cross-national data, interviewing policy-makers, and reviewing policy-papers concerning religious freedom, the authors highlight the necessity of sociology engaging with other disciplines in this type of research. By applying theories of religious pluralism, secularity, secularization, judicialization of religion, "lived religion", total institutions, and others, this volume contributes theoretical perspectives, sociological concepts and empirical analyses that highlight the development of religious freedom as an area of study in the social sciences.

This book is therefore a vital resource for students, academics, and general readers seeking to understand contemporary debates surrounding religion and secularisation in Australia.




