Introduction

Editors' Introduction

The years of the pandemic were a difficult time for scholarly networks such as ours. Fortunately, the ISA World Congress *Resurgent Authoritarianism: Sociology of New Entanglements of Religions, Politics, and Economies* in Melbourne, Australia, June 25 – July 1, 2023, stands for the resumption of in-person encounters.

This newsletter documents our Melbourne World Congress sessions, particularly for members not participating in the Congress. RC16 Sociological Theory sessions comprise 94 papers, including 89 oral presentations and five distributed papers, one-third of them jointly organized with other Research Committees: RC02 Economy and Society, RC03 Community Research, RC07 Futures Research, RC18 Political Sociology, RC24 Environment and Society, and RC35 Conceptual and Terminological Analysis.

Since 2010, the RC16 has granted the *Distinguished Contribution to Sociological Theory Award* to a thinker who has contributed significantly to sociological theory over the last two decades at least. Anthony Giddens is the winner of the 2023 prize. See the next page. Earlier recipients have been Zygmunt Bauman (2010), Alain Touraine (2014), and Jeffrey Alexander (2018)

International Sociological Association RC16 Distinguished Contribution to Sociological Theory Award 2023

2023 Award: Anthony Giddens

Anthony Giddens has made a distinguished contribution to sociological theory: he is the originator of the theory of structuration; a distinctive theoretical perspective intended to overcome some of sociology's basic dichotomies and perennial dilemmas. The theory of structuration has inspired subsequent programs of sociological theory and Giddens counts among the most cited social scientists, possibly the most cited contemporary sociological theorist. Before developing the theory of structuration in works like The Constitution of Society and Central Problems in Social Theory, Giddens made a major contribution to demonstrating and determining the contemporary relevance of classical social theory. These early works continue to be influential. Giddens subsequently sustained sociological theory's interest classical in formulating an interpretation of modernity and its consequences. Giddens was one of the first sociological theorists to clarify the general dynamics of contemporary globalization and his later writings addressed topics of global concern, including the politics of climate change and the future of the European Union. Giddens became a major public intellectual who sought to rethink social democracy in the guise of The Third Way, a political project that informed the British Labour government of Tony Blair and other European social democratic parties.

Giddens' institutional contributions to sociological theory are similarly considerable and were a significant part of the consolidation of sociological theory in the UK and globally. Giddens is a former Director of the London School of Economics, and he was the first Head of a newly formed Faculty of Social Sciences at the University of Cambridge. Giddens was one of the founders of the major academic publisher Polity Press, which has played a substantial role in the dissemination of European social and political theory in English. Polity Press have



published works by the most important contemporary European sociological theorists, like Bauman, Bourdieu, Beck, Boltanski, and many other major figures. Since 2004, Giddens has been a member of the House of Lords, having been made a Life Peer.

Giddens has undoubtedly satisfied the definition of agency that he proposed; the ability to make a difference or 'transformative capacity'. Giddens has formulated a substantial theoretical perspective, offered a distinctive interpretation of modern society, presented diagnoses of the times, and linked theory to practice. Giddens' theory of history and structuration theory, as well as his overall contribution to the field of sociological theory, have inspired the work of influential and substantial current sociological theorists, like Peter Wagner, José Maurício Domingues, Rob Stones, Andreas Reckwitz and Hartmut Rosa. RC 16 welcomes this opportunity to recognise Anthony Giddens' legacy and to give due recognition to his distinguished contribution to sociological theory.
