According to the relevant website (https://www.isa-

sociology.org/en/conferences/forum/rabat-2025/5th-isa-forum-guidelines/rules-for-isa-registration-grants-allocation), "registration grants can be allocated to individual ISA members in good standing (i.e., those who have paid the individual membership fee) and who are active participants in the conference program." Of course, your abstract must have been accepted by one of the 19 sessions organized by RC55 to apply for a registration grant.

The applicants must send an e-mail requesting a registration grant directly to the Program Coordinator (Joonmo Son, <a href="mailto:socioson@nus.edu.sg">socioson@nus.edu.sg</a>) by <a href="mailto:January 31">January 31</a>, <a href="mailto:2025">2025</a>. The RC55 Board will NOT consider late applications. Please note that the application for a registration grant can be submitted to only one RC/WG/TG.

The registration grants are separate from the Travel Grants Program supported by the World Society Foundation

(https://drive.google.com/file/d/1DtAN5R4Y2Owi2jHsESTD3V8P2YKpESLi/view). Thus, please submit your application for <u>either</u> the registration grant <u>or</u> the Travel Grants Program.

## Call for Travel Grant Applications due date: February 15, 2025

**Travel grants:** RC55 and the World Society Foundation will award a limited number of travel grants covering airfare, accommodation, visa, and ISA Forum registration fee (in full or in part) to support ISA-RC55 members who would otherwise find it difficult to attend the ISA Forum. Financial support will be provided for one author per accepted full paper using the most economical travel route. Researchers from the Global South (African, Latin American, and Asian countries, International Sociological Association country categories B and C), and doctoral and postdoctoral students are particularly encouraged to apply. Applicants must be RC55 members (in good standing) and present their paper on-site in one of the RC55 sessions at the ISA Forum.

**Submission procedure**: Applicants requesting a travel grant are invited to elaborate their ISA RC55 abstract into a full paper (25-30 pages, but no more than 8000 words) in English to be submitted by **February 15, 2025 (24:00 UTC/GMT)** to **Masayuki Kanai** (email: <a href="mkanai@senshu-u.jp">mkanai@senshu-u.jp</a>). The **application form** (Attachment 2) must be filled out and submitted by the specified due date. Authors will be notified by **March 15, 2025** of full paper acceptance/rejection. Authors should complete their registration for the 5<sup>th</sup> ISA Forum of Sociology by March 22, 2025 (24:00 UTC/GMT). Authors of accepted papers are eligible for financial support covering their travel, accommodation, visa, and registration costs (in full or in part; for one author per accepted full paper using the most economical travel route).

## 3. Obituary

Ruut Veenhoven, member of the RC55 board since 1998, passed away on December 9, 2024. Ruut was the President of RC55 from 2010 to 2014 and was a former Secretary and Vice-President. He made an outstanding contribution to the RC55.

Ruut Veenhoven was a pioneer in the scientific study of human happiness. His first publication on the subject was in 1970, when he studied sociology at Erasmus University of Rotterdam in The Netherlands. In 1984 he reviewed the available research in 'Conditions of Happiness'. This work laid the basis for the World Database of Happiness, which has been available on the internet since 1999. Veenhoven was a founding editor of the Journal of Happiness Studies that has been published since 2000. After his study of sociology, Ruut Veenhoven taught social psychology at Erasmus University Rotterdam. In 1995, he was appointed Professor of Humanism at Utrecht University and in 2000 he became Professor of Social Conditions for Human Happiness at Erasmus University Rotterdam. In 2011 he became a Special Professor at North-West University in South Africa. After reaching the age 65 in 2007, Veenhoven continued his research on happiness as an emeritus professor, working in the newly established Erasmus Happiness Economics Research Organization EHERO. The intellectual legacy of Ruut Veenhoven will be kept publicly available by the Foundation for the Study of Happiness (Stichting Studie Geluk) https://stichtingstudiegeluk.site. The last version of his World Database of Happiness will be stored in the Library of Erasmus University Rotterdam and will remain accessible on the internet.

## Ageing and Old Age in Contemporary Society (A Panorama of Swiss Society): Older people are living longer and feeling younger

The Swiss population is ageing. Life expectancy is rising and after retirement people can look forward to making active use of a number of years in good health (about 15 years on the



average). Today, older people (70+ years-old) believe that old age starts at the age of 80; thirty years ago the corresponding age was defined substantially lower: in the mid-1990s older people perceived the beginning of old age at 69 on average. Today, there is increasing diversity in lifestyles and household types in the post-retirement life phase. At the same time persistent inequalities in people's financial situation, health, and social participation are observed.

These are some of the findings published in the 2024 edition of the *Panorama of Swiss Society*, which focuses on the topic of ageing and old age in contemporary society. Following the tradition of the *Swiss Social Report*, the *Panorama of Swiss Society* series, jointly published every four years by the Swiss Federal Statistical Office, the Universities of Neuchâtel and Fribourg and the Swiss Academy of Humanities and Social Sciences, deals with core issues of social change, quality of life and well-being in Swiss society.



#### About the book

This open access book focuses on the impact of the COVID-19 pandemic on well-being, happiness and quality of life, taking into account the mediating effects of social inequalities. The volume brings together and into dialogue the different experiences and perspectives of countries and researchers from the Global North and South. Expert scholars from across the world have analyzed empirical data to reveal how the restrictions associated with the pandemic interrupted lives and livelihoods, and how different socio-economic groups and classes have been differently affected by the crisis. The chapters coalesce around four themes: the impact of COVID-19 on subjective well-being, life satisfaction and happiness in a comparative and longitudinal perspective; the impact of COVID-19 on workers' employment and well-being; sociability, civic participation and solidarity during COVID-19; and the impact of COVID-19 on children's and youths' well-being. Engaging with contemporary theoretical debates on well-being, happiness and quality of life, this volume is of interest to scholars working on well-being, happiness and quality of life, global and cross-national studies, the social impact of COVID-19, and on social and economic change.


